a. PRESENTATION from the Amargosa Toad Working Group - Michael Burroughs

Amy Lahoy, deputy assistant field supervisor for the USF&W discussed the petition to list the Amargosa toad under the endangered species act (ESA).

Michael Burrough gave a presentation on the steps required to place the toad under the ESA. He stated that a lot of work has been done to preserve the toad and the population of it is stable at this time.

Maria Zlotek, deputy D.A. gave a presentation that included a history of the boundaries of Beatty and the law as it exists today. Discussion and questions followed. *Note:* there is a section of tape during her presentation that is garbled.

c. Discussion, possible decision and direction to staff related to the status of the Beatty Area Plan – Cheryl Beeman

Cheryl Beeman stated that the area plan project got stalled because of the town boundary issue. When they left off they had decided to use the Amargosa plan as a base. The next step is to talk to Elaine and try to map out a time frame for finishing the plan. Cheryl mentioned that Amargosa appointed an area plan steering committee, and that Beatty may want to consider that.

d. Action - Discussion and possible decision to approach the BoCC to spend the previously set aside money in the amount of \$37,000.00 to be used on the ambulance hall for storage for Chamber, Museum, Town & Fire Department - Teresa Sullivan

TS made a motion to approach the BoCC to spend the previously set aside money in the amount of \$37,000.000 to be used on the ambulance hall for storage for Chamber, Museum, Town and Fire Department contingent upon developing a plan and consulting with Nye County Buildings and Grounds; second by RY; 4-0.
