# Minutes 11/18/09

THE BEATTY TOWN ADVISORY BOARD MET IN REGULAR SESSION AT 6:30PM IN THE BEATTY COMMUNITY CENTER.

1 Piedge of Allegiance

Meeting called to order at 6:30

2 Approval of the Agenda for the BTAB meeting of November 18, 2009.

TS motioned to approve with the pulling of items 7, 8)a)1), and 10)b; second by RY; 5-0

3 Action – Informal Election to elect two (2) BTAB members to fill vacancies due to terms expiring for Mike Lasorsa and Teresa Sullivan

Jan Cameron stated that she would be overseeing the elections and explained the voting process. Each candidate was given the chance to say a few words before the election.

Shirley Harlan stated that at the last Rhyolite Partnership meeting they discussed asking the town of Beatty to copyright the logo of "Gateway to Death Valley" as Pahrump has been using the same logo.

#### 10 General Business

a. Action – Discussion and possible decision to support a Proclamation for the BTAB to proclaim December "Toys for Tots" month in Beatty – Kay Handy

The Toys for Tots program is sponsored by the Marine Reserves. They have asked for Beatty's support. TS made a motion to support the proclamation; second by BB; 5-0.

b. Action – Discussion and possible decision to allocate monies for the BVFD "Santa Night" – Teresa Sullivan

This item was pulled.

Action – Discussion and possible decision on the consideration of a modular building as a
possible new clinic that was brought to the Board's attention from Nye County Building &
Grounds and all other matters properly relating thereto – Teresa Sullivan

TS has been informed by Bob Jones that a modular medical facility is available for \$133,615, plus transport. It needs new flooring and baseboards, but otherwise was renovated in 2005.

BB stated that the A/C units should probably be replaced as they aren't efficient.

ML stated that there is a problem with NV Health Centers clinic as they won't accept emergencies anymore.

TS stated that a solution to that problem does need to be found.

Some guy asked about a grant to put a new medical facility by the justice court.

TS stated that grant was from NV Health Centers and that they didn't include Beatty in their plan.

BB stated that NRS does allow for rural emergency clinics.

Shelly Archer suggested that maybe a committee should be appointed to look into the available building.

ML asked TS to get more information from Bob Jones. He stated that there will be substantial costs for the transporting, setting up, and renovations.

KH stated that perhaps the board should agendize an item to write a letter to the senators and legislators with the towns concerns regarding rural emergency care.

BB stated that maybe the community would want to change the existing clinic to a county-owned building.

TS stated that a bulk mailing could be sent out to survey the community.

d. Discussion, decision and approval to have a small celebration for sealing the items in the cornerstone at the 12-09-09 BTAB meeting. Approval for the town to pay for snacks and drinks not to exceed \$400. LaRene Younghans, David Spicer and Debbie Baker.

Debbie Baker stated that a formal ceremony was conducted for the cornerstone by the Masonic Lodge in October. There was not a lot of local involvement, and she would like to see a local celebration, including the elementary students and the high school band.
