Information received by the Town Office:

CERT (Community Emergency Response Team) Training will take place on April 11<sup>th</sup> & 12<sup>th</sup> at the Nye County Emergency Management training room in Pahrump, 8 hours each day. Class is limited to 31 people and it is free, you must be over 18 years of age and able to get to the training.

Town Square update – The property had new survey markers installed, we hope to start some work the week of February 17. There is another Community partner that offered to be involved and help with the project, Beatty Water and Sanitation (BWSD). This project has a lot of Community support; BTAB, BGID, Nye County Road Department, Nevada State Parks, and now BWSD.

The New Ambulance Barn is done and there will be an open house on Saturday February 21st and the BTAB will be holding their next meeting on Monday February 23rd at the New Ambulance Barn.

For Possible Action – Discussion and deliberation, to approve up to Ten Thousand Two Hundred Sixty Nine Dollars and Thirty Cents (\$10,269.30) to install two fire hydrants in locations selected by Chief Harmon; Beatty Volunteer Fire Department and Beatty Water & Sanitation (BWSD) Staff. – Beatty Town Office; Carrie Radomski

Carrie Radomski; Town Secretary – Stated that this is part of a Capital Improvement plan that was approved by the BTAB two budget cycles ago. Two hydrants were installed in town last year; this is a continuation of that project. The locations were selected by Chief Harmon and BWSD; Discussion followed.

- DG Stated he has no problem with this since it is a part of a plan made two years ago.
- CT Asked Chief Harmon if he looked at all the fire hydrants and stuff that they (BWSD) are looking at?

Chief Harmon - Stated he did, and he and Randy (RR) went out and scouted the locations.

DG – Asked if the hydrants are tested every year and went on to say he knows they are tested for flow or water volume a couple of times a year.

Chief Harmon - Stated they are tested twice a year by the water company; the Town pays them to do that.

# For Possible Action – Discussion and deliberation to institute a Community Center Equipment Use Agreement for the new TV and DVD player purchased for use in the Community Center. – Randy Reed

I don't know what we are going to do for next year. I am going to go ahead and try to push it to the BoCC, so that we can get one more person out here.

DG - Asked if anyone had any questions for the Sheriff (there were none).

Sheriff Wehrly - Introduced Undersheriff Moody.

Undersheriff Moody – Stated he really enjoyed coming out for the Boy Scouts event, he met a lot of folks and it was really enjoyable. If you are in town (Pahrump) he would be happy to show anyone around the Sheriff's Office.

George Wehrly – Stated that Undersheriff Moody is the Central Area Commander, so if you have issues with something he is the man to talk to, just like Frank was.

Diane McGinnis – Thanked Chief Harmon for bringing out the side by side (emergency equipment) and Melody Revera for manning the first aid tent, also Linda at the Chamber for stuffing all of the sacks that we gave out to the adults. The sacks had brochures about Beatty and other information in them.

DG - Asked where the Scouts came from.

Ms. McGinnis – Stated this was the Las Vegas Area Counsel, Beatty is the Northern boundary and Kingman is the Southern boundary and Death Valley is included. We did have a group from Lake Havasu and they said they will be up next year. Some of the vendors came up from Utah, so as far away as Orem. There were some adults that were dressed up in the garb of the Mountain Man era. They said that next year they may have a contest for the Scout that's the most authentic and they would get an award. The majority of the people did come from the Las Vegas area.
