 Action- Discussion and possible decision to use County Roads for "Vegas to Reno" event on Friday August 20, 2010- Casey Folks; Director, Best In The Desert

Casey Folks thanked the Beatty Town Board for allowing him to be here tonight and presented the Beatty Volunteer Fire Department with a donation of \$500.00 and Betty High School with a donation of \$1000.00. Mr. Folks went on to describe the "Vegas to Reno" one day event/race of 534 miles, this is the 14th annual "Vegas to Reno", starting Friday August 20, 2010. Mr. Folks stated there will be no pre-fun run; as this is the environmentally sound thing to do. Best In The Desert has applied for a permit with the Bureau of Land management, this event requires three field offices; Tonopah, Stillwater, and Carson City this year's lead is the Stillwater office. Mr. Folks provided the Town with a two million dollar insurance policy for the day of the event. Mr. Folks described the race start location and gave a general description of the race course. The race will start at 5:45am with the first motorcycle, followed at 9:30am by the first car or truck. They anticipate approximately 300 entries. The start will be watered and all roads will be graded from the start of the race at Fluorspar Road all the way to mile marker 44. Within approximately five to ten days from the day of the race re-grading will take place. At mile marker 44 Best In The Desert will take over with their graders and move forward up into Esmeralda County and beyond. Mr. Folks will be going before the Nye County Commissioners and Esmeralda County Commissioners on July 6, 2010 for approval. Best In The Desert will clean up the course within five days of the race. Mr. Folks stated that Best In The Desert has complete first aid coverage for the entire event. Mr. Folks welcomed observers from the town to the race: Discussion followed. TS - inquired about vendors at the start of the race last year, and asked if Mr. Folks considered contracting with local businesses for this year's events. Mr. Folks stated that he did not contract with any vendors last year but welcomes local businesses and civic groups; they can call or they can go set up at the Starting Line early in the morning without calling; Discussion followed.

BB – Moved that we recommend the plans for 2010 Best in the Desert "Vegas to Reno" race for August 2010 to the Board of County Commissioners for approval; Second EG; 3-0
