a. Action - Discussion and possible decision regarding incentive package for new Provider at the Beatty Medical Clinic and all matters pertaining thereto. - Teresa Sullivan

TS – Stated the good news is we will have a Nurse Practitioner in Beatty in very short order. Ginger Warren was offered the position and accepted. Ms. Warren has fourteen (14) years nursing experience in Montana, and just completed her Nurse Practitioner education. Ms. Warren is thrilled to come to Beatty and be a part of the community.

TS – Stated several years ago this board approved an incentive package in the amount of Fifty Thousand Dollars (\$50,000.00), the Board of County Commissioners approved a match to that in the amount of Fifty Thousand Dollars (\$50,000.00). The incentive package was left open to fit the needs of whomever the provider was going to be.

TS – Read the list of possible incentives; J-1 Fees, Tuition Reimbursement, Housing in the amount of Four Hundred Dollars (\$400.00) per month, a negotiable sign on bonus, and a retention bonus which was Fifty Thousand Dollars (\$50.000.00) after five years of service.

TS – Stated we are waiting for confirmation from the County that the funds that were committed to in 2008, by the County Commissioners are still available; Discussion followed.

DG - Motion item 9a to pay a Twenty Thousand Dollar (\$20,000.00) sign on bonus, at the beginning of the second, third and fourth year; Five Thousand (\$5,000.00) per year. On year five through year 7, Fifteen Thousand (\$15,000.00) per year, each to be split 50/50 per 2008 agreement with County Commissioners; Second EG; 4-0

 Action Discussion and possible decision to review, provide, and submit recommendations for revisions to; Nye County Code Chapter 8.04, Fireworks, and all matters pertaining thereto, to the Office of the County Manager at the request of Richard L. Osborne, Nye County Manager. – Beatty Town Office; Carrie Radomski

Carrie Radomski – Stated the Office received a request from the Nye County Manger for input on this specific ordinance 8.04 pertaining to fireworks. They are reaching out to the local areas for input. The input must be submitted by June first.

DG – Stated that the time allotted to comply with the request for a response is unrealistic, the County is aware that the BTAB meets every two weeks. The request was received May 18th and the response can be submitted no later than June first, lack of planning on their part does not mean that it is an emergency on ours.

KC - Asked what is wrong with the ordinance; Discussion followed.

DG - Asked what is meant by a shooter site; Discussion followed.

TS - Stated that Beatty never submitted a designated site; Discussion followed.

EG- Stated one thing that was puzzling was the time and date limitations on retail sales listed in the ordinance, sales are taking place outside those designated dates and times; Discussion followed.

EG – Motion to provide and submit input to the Nye County Board of County Commissioners regarding Nye County Code Chapter 8.04 Fireworks; that timely manner, the term regarding Shooters Site remain "May", Beatty at this time chooses not to have a shooters site, and that item 8.04.100 limitations on retail sales, that the dates and times allotted for the sale of fireworks either be enforced or revised; Second KC; 4-0
