i. Beatty Area Plan

Next meeting is scheduled for September 26^h at 5:30pm

ii. Beatty Economic Development

Albert Verrilli – Stated that on the 31st of July two Commercial Realtors from Coldwell Banker located in the Las Vegas area completed a site visit of the BEDC property, a formal appraisal was not completed at this time. They did state that commercial property in Las Vegas was ranging from One Hundred (\$100.00) to Fifty Dollars (\$50.00) a square foot depending on the location, commercial building square footage is what is used to determine the value in the Las Vegas Area.

Mr. Verrilli – Stated he did a rough calculation of the approximate Thirty Seven Thousand (37,000) square feet of commercial building space at Twenty Dollars (\$20.00) a square foot would equate to approximately Seven Hundred Forty Six Thousand Dollars (\$746,000.00). They also discussed the employment situation in Beatty.

Mr. Verrilli stated he described our workforce as elastic, if employment is here the workforce is here.

Mr. Verrilli – Stated he has been invited to, and plans on attending an energy conference in Pahrump on November 9th, Mr. Verrilli will be a presenter at the conference.

TS - Asked if the property is formally listed with Coldwell Banker.

Mr. Verrilli – Stated not at this time; Discussion followed.

TS - Asked if it is BEDC's intention to list the property with Coldwell Banker or a different company.

Mr. Verrilli – Stated if they (Coldwell Banker) want to list the property, but BEDC would prefer to get a company that they know is interested and wants to go after this type of business.

EG- Confirmed that out of the three (3) commercial real estate agents out of Las Vegas, only one came up and had a visit with you, do you think they are a company that has the resources to list the property. The three months are just about up and a decision will need to be made about the next quarter or the rest of the year taxes. A decision really needs to be made about listing the property, the first quarter taxes were paid, the rest of the years taxes were contingent upon the property being listed with a commercial real estate agent.

iii. Beatty Medical Clinic

Beatty Water and Sanitation District (BWSD) was kind enough to loan a map of the town with addresses for each residence on it, Elaine of Tara Spectra had provided the Town Office with a smaller map of the town that had parcel numbers on it, Elaine believes she can provide the same type of map but with addresses instead of parcel numbers. This would be a map that could be distributed to all emergency services departments/agencies. If Elaine cannot produce a map the alternative would be to take the map that is on loan from BWSD to a Kinko's or a place like that and have it copied.

- EG Stated that she spoke with Dave Fanning about numbering on the street, his first question was don't we have an Emergency Response Handbook, which should have a map that would list every address.
- EG Stated at this time we don't have a handbook and this map would serve in that capacity; Discussion followed.
