Carrie Radomski – Explained that in 2009 the Board approved the purchase of seasonal banners for up to four seasons; the patriotic banners would be one of those seasons.

Ms. Radomski – Presented the two quotes obtained and the banner options available in those quotes; Discussion followed.

 - TS Stated she has concerns that the old building is supposed to have a remodel done, and would like all the work in the building to be done during that remodel; Discussion followed.

e. Action - Discussion, deliberation and possible decision to aid Beatty High School Student Council by sponsoring their participation in Rachel's Challenge. - Beatty High School Student Council; Ana Martinez, Teresa Sullivan

Anna Martinez; President of the Beatty High School Student Council – Stated that the total cost of the program is Four Thousand Dollars (\$4,000.00). The Student Council has raised; One Thousand Dollars (\$1,000.00) from the Gear Up Program, Five Hundred Dollars (\$500.00) from Student Council fund raising activities and will receive an Eight Hundred Dollar (\$800.00) multi-school discount if more schools in the area participate in the program. That leaves the Student Council One Thousand Seven Hundred Dollars (\$1,700.00) more dollars to raise; we are asking for the Town Board's help to raise the money.

Ms. Martinez – Stated she first heard about Rachel's Challenge at, Student Council State last year. At first she thought she was going to hear the same old boring lecture about the "Golden Rule", like everyone else in the room. Her opinion and everyone else's in the room changed dramatically after the presentation, there was not a dry eye in the room, the impact it had on everyone was unexplainable.

Ms. Martinez – Explained the difference between this program and other "Golden Rule" programs. This program does not try to educate with lectures, they tell us a story about the Columbine Shooting victim named Rachel Scott, and they talk to the audience about what kind of a person she was and her theory about how to treat others. They target the students' emotionally, so they feel sympathetic toward what happened and her cause. This allows the students to make a stronger connection and take the "Golden Rule" to heart. This is a nationally recognized foundation, because of the great impact it is having on High Schools and their communities. Many students in Beatty and the community would benefit by learning to respect each other and taking the time to understand each other.

EG - Asked what Rachel's challenge is.

Ms. Martinez - Stated Rachel's family created this program in her honor as a way to spread her philosophy of being kind to everyone, and understanding you don't know what is going on in someone's life that may cause them to act out, or withdraw.

EG - Asked what the challenge is, what do you do?

Ms. Martinez – Explained that depends on the program you select, the Student Council is trying to get option B which is a full day program; a school wide assembly, leadership training, and a community assembly. The challenge that they do is; they challenge the students to accept Rachel's challenge, and for us to act the way she did toward others.

DG - Asked what does the Four Thousand Dollars (\$4,000.00) cover, does this go to the foundation for them to come out and present the program?

Ms. Martinez - Stated it covers travel costs.

TS - Stated Ms. Martinez did a great job explaining the program.

TS - Stated they will do two assembly's one for the Middle School Students and one for the High School Students, they do a leadership workshop for up to one hundred students, which is nearly the whole High School, and then the Community Event; Discussion followed.

Ms. Martinez - Stated the tentative date is Monday December 12th; Discussion followed.

DG - Motion to give the Student Council for participation in Rachel's Challenge Fifteen Hundred Dollars (\$1500.00); Second CT; 4-0
