2 For Possible Action -Approval of the Agenda for the BTAB meeting of February 25, 2013.

RR - Motion to approve the agenda of the Beatty Town Advisory Board for the meeting of February 25,2013, and to pull item 5 emergency items and item 4 the minutes dated February 13, 2013; Second CT; 4-0

DG - Stated for the record Erika Gerling is not here tonight.

Charlie Cook – Asked if we had any luck with the letter to NDOT requesting the reinstallation of the flashing red light, and stated he does not believe we will have much luck.

Mr. Cook – Suggested we place an item on the agenda to send a letter to NDOT to request the road be painted with warnings, one up at the Rebel and at the stop sign and one from the other direction, about the upcoming stop at the center of town.

Mike Wehmeyer – Stated the County partially constructed a new facility for the Ambulance Service; we have a foot print, pad, building and nothing else. He understands that several bids were received to complete the project but the bid amounts were too high. He recently read in the Pahrump Valley Times that the County is planning on spending about a million and a half dollars on the construction of a new IT building with funds left over from the bonds issued to construct the Pahrump Jail. He also understands that there is approximately \$140,000.00 in grant money that was originally obtained to complete the Ambulance Hall, it is about to expire in April. He is urging the BTAB to write a letter to the BOCC requesting they use some of the money left over there to match the grant and fund the Ambulance Barn. He knows there has been some talk about the possibility of using volunteer labor to complete the barn, but the last time we tried to do that we pretty well got shut down. He concerned that by the time the details are worked out the money to purchase the materials will be gone. He also understands that the Town has a substantial investment in that building as well. He also noticed that a backup generator and heat/ac is included in the IT building plans. The backup generator was deleted from the Ambulance Barn plans as a cost saving measure. It's all well and good to have nice computers and internet communications and stuff, but if our Fire and Ambulance equipment can't get out of the buildings because the door won't open, if we can't communicate in the case of an emergency, all the computer equipment in the world isn't going to make any difference.

# 7 Secretary's Report

a. Carrie Radomski – Stated that the office received a letter and booklets from James Oscarson our Assemblyman, District 36; The Nevada Politics Guide to the 77<sup>th</sup> Legislative Session. This next item is already on the Community Calendar on the town website, the Museum will be hosting an art exhibit "Stop the Car Dad", and the reception will be held on March 23, 2013 at 3pm at the Museum. The exhibit will run from March 22<sup>nd</sup> through May 17<sup>th</sup> it will be available for viewing from 10am to 3pm. The Recreational Trails Grant funding is available for 2013 through the Nevada Division of State Parks; this is the same entity that awarded the Town Square grant.
