- 2 For Possible Action -Approval of the Agenda for the BTAB meeting of March 25, 2013.
 - RR Motion to approve the agenda of the Beatty Town Advisory Board for the meeting of March 25, 2013, and to pull item 5 emergency items; Second CT; 4-0
 - DG Stated for the record Kelly Carroll is not here tonight.

Charlie Cook – Asked that the Board consider videotaping the Town Board meetings. He has the support of Commissioner Wichman and he checked with Suzy McCoy, who maintains the Town website, and she will post the video to the town website at no charge. It would appear as a regular video so you could roll past anything you didn't want to watch, or freeze it or down load it to your disk. Again, it would be no charge you would just have to buy the camera equipment.

- EG Asked why do we need to do that.
- Mr. Cook Used Commissioner Wichman as an example, she lives 86 miles north of Round Mountain and it is difficult for her to be here for the meetings because of the distance. If she had access to the Town meetings, without having to drive 400 miles, this could help a lot. She would know what is going on in the Town and could interact better with the Town Board.
- EG Clarified that Mr. Cook is talking about live streaming video; Discussion followed.
- Mr. Cook Stated he was talking about video that would be available for viewing after the fact; Discussion followed.
- EG Stated she does not see the benefit of posting a video for viewing after the fact because after the fact you can currently get an audio recording.
- Mr. Cook Stated that to him audio is not the same as video, it would give the Commissioner a vision of what is going on as it happens, it would only be one or two days later. If you have something you want to express to her it would be available and she could act on it.
- DG Stated it would need to be looked into, and he is not sure of the benefit of it.
- DG Suggested Mr. Cook fill out an agenda item and bring it up and we'll discuss it and look at all the pros and cons and go from there.

7 Secretary's Report

- a. Carrie Radomski Stated that the grant is still pending for the Town Square Project. The office was contacted by Fusion Staffing, which is the group who handles the staffing for Tough Mudder. They are still looking for employees, there are a couple of shifts on Saturday and Sunday, or you could work the whole day. The pay is \$15.00 per hour, if you know of anybody who might be interested please let them know about this opportunity. They (Fusion) are struggling to fill all the needed positions so I put them in contact with Tim from the Nye County Communities Collation. Tentatively, Tough Mudder representatives will be here for the first BTAB meeting in April and will hold a Business meeting before the BTAB meeting that same day. On April 22nd we have a business ordinance workshop tentatively scheduled to take place before the BTAB meeting.
- Lorinda Wichman Nye County Commissioner Stated that she knows that there are concerns about the budget and the unaudited reports. She has confidence in Nye County employees currently working on it. Any adjustments made to the numbers due to the audit should be minor.

BTAB Minutes 03/25/13

For Possible Action - Discussion, deliberation and decision to send a letter to the Tonopah Field Office of the BLM in support of the Corvus Gold proposed exploration drilling at the North Bullfrog Project. - Corvus Gold: Carl Brechtel

Wiley Skewes Geologist; Representing Corvus Gold – We are hoping for you help in public comment for our proposal for a permit that has been filed with the BLM (Bureau of Land Management) office. The proposal is to increase exploration of the gold resources. The permit will allow us to continue drilling to find the resource and to do the engineering work to determine if the economics are there for the mine. We are hoping that Beatty can help Corvus Gold by expressing its support for the project, and to say that brining in funds to the community as a result of the employees staying here while the work in this project is taking place, is beneficial to the Town.

EG – Stated that the information she read in the BLM report indicated that all of the exploration drilling in sensitive areas will be a temporary disturbance, and that those things would be reclaimed. The support at this point is for the exploration drilling, not production.

DG – Stated that he has a copy of the sample letter provided by Corvus, and he has an objection to the statement about the meeting with the Beatty Water and Sanitation District (BWSD), he does not feel we should mention the BWSD. The letter states that we (BTAB) feel that the community is well informed about the project, he is not confident enough that the community at large is well informed. He has no problem with a letter of support for the exploration but feels we should not even mention the BWSD; Discussion followed.

DG - Asked for audience comment.

Shirley Harlan – Asked some questions about an article in the Mirror and statements made by Russell Meyers the president of Corvus Gold at the Commissioners meeting. There are discrepancies in the statements made by Mr. Meyers and Carl Brechtel at the March 7th community meeting that took place here in Beatty. Mr. Meyers told the Commissioners that he estimated the number of local employees would be 150 to 200 and at the March 7th meeting Mr. Brechtel estimated the numbers at 15 to 16.

Mr. Skewes – Stated that his guess is that whoever was referring to the lower number is referring to an exploration project. Whereas the person who is anticipating 150 to 200 people is probably looking a little farther forward; for example if the exploration goes well and we are able to put in a mine site the larger number may reflect how many people that mine site would employ; Discussion followed.

DG - Reiterated that this item is only to decide if a letter of support, of the exploration project, should be sent to the BLM.

Ms. Harlan - Stated that she understands that but hoped to get some answers to her questions; Discussion followed.

RR – Motion to send a letter to the Tonopah Field Office of the BLM in support of the Corvus Gold proposed exploration drilling at the North Bullfrog project, with the exception of the Beatty Water and Sanitation District reference; Second CT; 4-0

10 General Public Comment

Diane McGinnis; Beatty Medical Clinic – Stated she will be out of the office Thursday and Friday this week and Monday through Friday of next week, she will be teaching a wilderness medicine course.
