**5 Discussion – Review of Beatty Ordinance Chapter 19.08 Business Licenses and Regulations.**

DG - Asked the Board if they have reviewed the ordinance as it is and if they have any comments.

CT - Stated she thinks we should table this and leave the ordinance alone.

RR - Stated he agrees with CT.

EG - Stated that even though we may not want to make any changes now, the TAB should look at it because eventually there are things that will need to be changed/updated like; the issuing agency, the fees, where the revenue from the fees is allocated; Discussion followed.

KC - Stated it is all enforced by the Sheriff's Office, and it's not being enforced, making changes to it won't change the enforcement; Discussion followed.

DG- Stated he has lots of notes about it; one thing he thinks that could be changed would be the *quarterly issuance* to annually issuance. The list of types of businesses needs to be reviewed and addressed.

DG - Suggested we take more time to read and review, and asked Carrie Radomski if the County requested we review this. Carrie Radomski - Stated that last year there was a request, but there is a new board sitting and she has not had any additional requests.

CT - Recommended that as the TAB is reviewing the Beatty ordinance they consider using the Gabbs ordinance as a guide for possible modification; Gabbs and Beatty are similar communities.

DG - Stated this needs a lot of work and consideration; it can be brought back at some future date for additional workshops.
