DG – Reviewed things to consider handout and stated that he would prefer to go with a combination of commercial and high grade residential equipment.

Audience – Stated that commercial could require inspections.

Audience – Asked what are BTAB's goals; how big, who will use it, how far do you want to go?

DG – Stated that one idea is to utilize the existing space and upgrade the equipment.

EG – Stated there are few large events that use the kitchen and only some of those are paid events, most are non profit organizations.

Audience – Stated that the existing kitchen was built to fit the old building, and a new kitchen should fit the size of the new building.

Audience – Asked to what degree can we cook in the existing kitchen and how many people can fit in it? If you are looking at a physical expansion it should fit the capacity of the new building; Discussion followed.

DG – Recapped some equipment preferences discovered during the workshop; commercial double oven (convection preferable) with 6 burners, double door refrigerator, single door freezer, commercial under cabinet dishwasher, 3 compartment sink, separate hand washing sink, ice maker, and no garbage disposal.

DG – Asked if the group would like to schedule another workshop and when; Discussion followed.

DG – Suggested that we hold off a couple of weeks prior to scheduling another workshop; Discussion followed.
