7 Presentation; Valley Electric - Update on Tolicha Peak Distribution Line

Kristen Mettke VEA Engineer – Stated VEA is currently working on the installation of a double circuit line that covers 35 miles. The first circuit is for the Air Force and the second is for Beatty. In Town construction that will take place on Ward is scheduled to start in the next week and will take several weeks to complete.

Audience - Asked if this work will increase the available transmission capacity.

Ms. Mettke - Stated yes they did plan for additional loads. Work is also taking place to upgrade the Beatty power station.

Audience - Asked if some of the lines will be retired.

Ms. Mettke - Stated they will.

Ms. Mettke - Introduced Tim Rainey, General Foreman for PAR Electrical Contractors, Inc, they will be doing the work in Town.

Tom Rainey - Stated that if anyone has any questions or concerns while they are working in Town please contact him.

Mr. Rainey - Gave the Town Office some business cards.

Carrie Radomski – Stated that she received a comment from Shirley Harlan about the work done so far on the transmission line. Ms. Harlan wanted to be sure that VEA received her congratulations on the work by Pioneer Road, there has been very little disturbance and she wanted to thank VEA for its attention to and care of the environment.

iii. Beatty Habitat Committee

Carrie Radomski – Stated Shirley Harlan apologized for not being here, and reported on her behalf; that the grant from the NPS – Recreation, Trails & Conservation Act has been applied for. It is not a money or engineering grant, it is a grant for design/landscape ideas for the trail route that is presently planned. This will be a similar process to the design charette held here in 2004. The project will involve the town's people before, during and after through town meetings, so that locals can offer input, ideas, and questions.

iv. Beatty Library

Carrie Radomski – Stated Shirley Harlan apologized for not being here, and reported on her behalf; the library had a very busy summer. The summer Reading Program was a great success, 30 kids signed up for the program and between 15 and 22 attended each meeting, 135 books were read by individual readers. In addition to books, there were games, crafts, DVD's, treats, and a magician came to perform. The program was extended for a week, because of its popularity. The adult games program has been an on-going activity, and will continue into Fall at 1pm every Monday. A Library website has been created by John Wirth and Diana Smith, Assistant Librarian. The initial expense has been donated by a private person. The Trustees are continuing to work on forming a 501.C3, establishing the library as a non-profit entity, which may make donations deductable.

Dr. McGinnis – Stated that Rob Phoenix was here last week. Dr. McGinnis will be on out October 16th through the 18th and the week before Beatty Days. Starting in September the clinic will be getting a software update.

This conference will give each attendee an additional 20 educational units (ECU). Continuing education is a requirement for all EMTS to retain and renew their certificate/licenses. They are asking for \$900.00 which is an estimate. They are hoping to use the County Car which will reduce cost; mileage would not have to be paid.
