David Spicer - Stated we have good news on our front. We've had some good advances on our recreation trail program. We got tired of waiting around for the BLM (Bureau of Land Management), doing nothing, so we pulled a high level meeting of the State Director of Transportation and also a recreational planner in from Reno down to the Las Vegas office on neutral ground and we had Barrick there also in Las Vegas, we had USDA, we had quite a few other organizations there and State Directors at all levels talking about the fact that we are kind of a disadvantaged community up here, having to do all of the expenditures ourselves to make things happen, while everybody else is getting assistance from federal agencies and everybody else to do recreation planning and whatnot. A result of which we now have the State has stepped in and elevated our project to a priority level as far as activities is concerned. They have appointed a GIS person and some mapping specialists to start with. Which is, the fact being that we've had our documents in their hands since June of last year, and they didn't even open those documents until two weeks before Christmas, which is when the meeting was held and they recognized that nothing was happening, so that's the good news. Subsequently we've had, signage is now on the trails, we've got the signs out there, and we will have a news article out as soon as we get to completion, they forgot to send the miles stickers down, so they need to have miles put on them. It just says mile, not how far you have gone or how far you've got to go so as soon as that happens we'll have an article on that. Valley Electric has decided to come forward as a corporate sponsor involving themselves in our community reconstruction program here. They are coming in with a substantial donation; I'm not quite sure how much yet it's multiple thousands, so we continue our program with the consultants we've got, mapping groups, archeological studies, biological studies all of these things have to occur. There is an agreement that we use the existing trail that we've got as a template so once those are approved then it's real easy to cut and paste and say okay we'll do the ones over here that way and the ones over there that way. That's substantial direction from the right source. We also have outside organizations; racing groups, marathon groups, NICCA, the National Scholastic Cycling Association, and Fat Tire Association. Marathoners who want to come to Beatty, they've all sampled the trails, they've sampled the community, sampled the restaurants, the hotels and motels and they say we would love to come there and put events on. That's good news on our front right now. We're making some headway and I think that the result is going to be a good one, recognition, and we would hope to have happen. One last thing, the USDA has sent us information to see just how we might be able to qualify as a community in what we are doing here. So we will be evaluating what they can do, how they fit in as some of these specialists will be talking with us. How we might be able to format some of those things and do what we are doing. So that's the news for the moment. We are starting off on the right leg for the New Year.

DG - Stated thank you for the update Dave.

Mr. Spicer – Stated also, Barrick has made another \$25,000.00 donation to our non-profit just after the first of the year and that's because we are making some headway and that's what the goal is all about.

EG – Stated I just wanted to let you know anybody that's been out there, people from out of state, your presence is really great on Facebook. Which I'm very new to but they post some pictures and glowing comments about the great time they had out there. You know my big thing is getting the connect-ability (to Beatty).

Mr. Spicer – Agreed, you bet it is connect-ability. Speaking of which one last thing on the Close Up situation, Barrick wants to make a three, four or five thousand dollar donation, we're not sure of the exact number. They (the students) are lacking right now between seven and nine thousand dollars according to Teresa at the High School. So they are going to come up with four or five I myself, my organization, will put up twenty five hundred to three thousand (dollars). We know we will make that so the kids can go there (Washington D.C.). We've got a couple of other groups that we are going to reach out to which would give them spending money and if nothing else they can save it for later. We were talking about what they can do in the community. We need to have them have a sense of ownership in earning this money so we will have some sort of community project that we are going to have them do. Teresa at the High School is going to have a meeting with the parents and the children, I guess tomorrow and again in a week, about ideas of community reinvestment; discussion followed.
