Carrie Radomski; Town Secretary – Stated the office received a certificate of appreciation for the Beatty Community Center from the Beatty Boy Scout Troop, Pack 777. EPA public comment notice for the US Ecology proposed expansion, comment period open from April 27,2016 through June 10, 2016 copies available in the Town Office. U.S. Nuclear Waste report to the U.S. Congress and the Secretary of Energy titled - Technical Evaluation of the U.S. Department of Energy Deep Borehole Disposal Research and Development Program, it is available at the Town Office as well.

#### 9 General Business

 a. For Possible Action – Discussion, deliberation and decision to approve the Beatty Town 2017 fiscal year budget (July 2016 to June 30, 2017) for all Town Departments; Beatty Volunteer Fire Department, Beatty of Chamber, Beatty Museum. – Beatty Town Office; Carrie Radomski

Carrie Radomski; Town Secretary – Stated we received the final, but not exactly final yet, budget from the County. They did make some adjustments to the budget that we submitted to them. All of the adjustments had to do with revenues and beginning fund balances none of them had to do with expenditures. That being said they made a slight modification to our property tax revenue it was reduced by a hair. They also made an adjustment to the general fund beginning fund balance which went up a bit and then the room tax fund which is the Chamber, the Museum and the Town, not the Capital that went down by about ten thousand. The ten thousand dollar adjustment has come out of the Town services and supplies, the Chamber and the Museum budgets are staying the same as what they had originally requested. If this is approved by the BTAB we will submit this back to the County and then I will get a final, final after they do all of their work that goes to the State. That one won't require approval, that one will be just letting you know the final numbers. They (the County) did not change any of our expenditures which is our big thing.

EG – Stated we have to trust the State/County revenue numbers, those are numbers that are given to us they are not numbers that we create. On all of our expenditures we were really, really good we all did our budgets and we are within our budgets. They are saying that we have more money but we don't know that.

DG - Stated it's not in the Bank.

EG- Replied exactly.

CT - Asked what was the reason for the \$10,000.00 change in the Tourism Fund?

Ms. Radomski – Stated I am not sure. I have not received a call back from Pam or Savannah yet. It appears to me that there was a beginning fund balance adjustment and I'm not sure what caused that; Discussion followed.

Ms. Radomski – Stated net, net we ended up with an overall increase and so what they did and what we are leaving it as because we agree, again there were no changes to our budgeted expenditures, they just bumped the ending fund balance up, which means basically they put it in our savings.

EG - Stated yes, so we can't spend that ending fund balance that's what we will start next fiscal year 2018 with.

Ms. Radomski – Stated if we spent everything that we have budgeted to spend, our ending fund balance is what would stay in our savings for us to start next year with; Discussion followed.

EG – Stated I'm very comfortable with the explanation that Carrie figured out. On the expenditures on the BTAB final approved expenditures will remain and on the revenues we will use the County/State numbers but those numbers are subject to change.

RR - Motion to approve the Beatty Town 2017 fiscal year budget for all Town Departments, the Volunteer Fire Department, the Chamber and the Museum; Second CT; 4-0

b. For Possible Action – Discussion, deliberation and decision to approve a request for funding assistance in the amount of four thousand five hundred dollars (\$4,500.00) for the purchase and installation of an AC unit and duct work in the Beatty Museum addition. This would be a 50/50 split with the Beatty Museum. – Beatty Museum; Amina Anderson

Amina Anderson; Beatty Museum Manager – It's not quite 50/50 when you look at the two quotes, but of the two there's only a \$450.00 difference.

DG – Stated I was looking at these both and I personally, there's one that the total amount is \$9,950.00 and the other was \$9,500.00, I personally like the way that the one for \$9,950.00 is written up. It explains more in detail, it tells you that you are going to get a York 5 ton package where the other one just says it's a 4 ton it doesn't tell you what kind it is. Unfortunately we can only go \$4,500.00 but I think that the 5 ton is better than a 4 ton unit; Discussion followed.

EG – Stated I have an issue with one of the bids, there's no name, address, and contractor license I have a problem with that and also there is a warranty statement on the other bid.

DG - Clarified all we are doing is approving \$4,500.00.

EG - Stated yes it will be up to the Museum to choose the vendor.

DG - Asked does the Museum have anything to say about that (the vendor)?

Ms. Anderson - Stated they are leaning the same direction that you are.
